DEAN'S MESSAGE

A very happy new year to the SAHSOL community. I would like to take this opportunity to extend my warmest wishes for good health and more success in 2023. As we begin the new Spring term, I want to acknowledge everyone for their dedicated efforts to carry out their work, research and study through what was a long fall semester. We have accomplished many things together in the first half of this academic year, and this effort will continue through the Spring term as well.

Members of the Shaikh Ahmad Hassan School of Law participated to a further extent than ever before in the summer semester offerings this year as well. Others were involved in research and study further afield. Curricular reform has been effectively implemented in a staggered manner so that incoming students for the batch of 2025 have been offered a fully revised programme of study for the 3 year LL.B component of their BA-LL.B degree. Alongside this, the structure of programme delivery has been revised so that core, fundamental classes are now almost exclusively being taught by permanent faculty members and we are able to offer a far more diverse set of elective courses organised in five clusters for our senior and super-senior students. Altogether, these changes have been envisioned as a means of enabling the school to grow in several directions – towards the offer of new joint programmes with other schools as well as specialised graduate programmes. Alongside this future planning, we have endeavoured to ensure that more targeted advising support is being delivered to our students, particularly drawing into the fold pre-law students as well as ensuring that vulnerable students are being tracked more closely over the course of their studies.

Here are a few updates from the fall semester of the academic year 2022-23, celebrating just some of the significant events of this time. As we look forward to the second half of this coming academic year, I hope that we'll grow closer and can draw upon mutual support as we face what seem like exceptionally difficult circumstances ahead for the country.

LEGAL SCHOLARSHIP AT SAHSOL

A major set of events has been unfolding this year to commemorate the path-breaking research publications of SAHSOL faculty members. This comprises book discussions for volumes that have appeared in previous years as well as two book launches of new volumes by faculty members.

Faculty associated with the Shaikh Ahmad Hassan School of Law have been pioneers not only in forging a unique programme of study but in the development of outstanding legal scholarship. These books, two of which were launched here in the fall semester and others published over the last decade, are all outstanding contributions to the developing field of Pakistani legal scholarship.

Ranging over fields that include human rights, the laws of war, commercial finance, criminology and constitutional law and theory, these are contributions that have made an impact on the way we understand these fields while also informing global spheres of comparative legal studies. Over the coming spring semester, we are staging a series of events to showcase our faculty and scholars in conversation with interlocutors from practice and academia.

Book Discussion: *Criminal Punishment and Human Rights Convenient Morality* (Routledge, 2019) by Dr. Adnan Sattar

This discussion was moderated by Mr. Saroop Ejaz and stressed the need for reimagining human rights scholarship and practice in a way that is more sensitive to the negative consequences of expanding the state's punitive power.




LUMS LAW JOURNAL | VOLUME NO.9





10 Years of the Baldia Town Tragedy: Movie Screening of "Discount Workers: A Fight for Justice in Global Supply Chains"


Focused on the fight to gain compensation for families of the victims of what is arguably Pakistan's worst industrial disaster, 'Discount Workers' is a film that pays homage to the resilience and fortitude of those who keep up the fight.

In the discussion that followed the film, Directors Christopher Patz and Ammar Aziz spoke of the politics that informed the making of the film and the gains since this litigation lost — such as new legislation in Germany that makes retailers responsible for conditions in their supply chains. SAHSOL faculty members, Dr. Muhammad Azeem and Professor Hiba Akbar contributed an expert opinion to litigation that was undertaken in Germany, and spoke further of that experience.



Workshop on Navigating the Law in Pakistan as a Microentrepreneur

A half day workshop for female microentrepreneurs was convened on November 28, 2022. As a collaboration between Kaarvan Crafts Foundation and SAHSOL, the sessions intended to offer female artisans and entrepreneurs a chance to build a legal acumen and maneuver their way in the local business market. 




FAGULTY NEWS

Dr. Muhammad Azeem has been granted tenure and promoted to the position of Associate Professor. This is great news for the law school as he has been an amazing advocate for so many constituencies across the University and well it. In addition, Dr. Azeem's scholarship and contributions to debates in international law, domestic social protection and in other fields is of considerable value to



all of us, to academic communities everywhere and of course, to his students.

Professor Sikander Ahmad Shah successfully defended his PhD in Social Sciences at Indiana University, USA during Fall 2022. His thesis investigated liberal legalism and local centripetalism in Pakistan.



Our faculty has been exploring international linkages for interdisciplinary endeavours between Shaikh Ahmad Hassan School of Law, LUMS and Maldives National University. Senior Management at MNU invited Mr. Uzair J. Kayani (Head of Department, Assistant Professor) for a discussion regarding the collaborations between the universities on areas of mutual interest. 


Dr. Faiza Ismail presented 'History of English Commercial Courts and Islamic Finance' at INCEFI, Malaysia and 'Challenges of Globalization: FATF and Money Laundering Laws in Pakistan' at the Asian Law and Society Association's annual conference in Vietnam. She also participated in a conference 'Beyond the Greylist' organised by RSIL and contributed on regulations of virtual



currencies by the State Bank of Pakistan. Dr. Ismail received FIF 2022 for a case study on Money laundering laws in Pakistan and FTG first quarter for a visit to Kuala Lumpur, Malaysia.

Dr. Adnan Sattar has been nominated as a member of the committee constituted by the Social Welfare Department, Government of Punjab for deliberation upon the Child Protection Bill of 2021. Dr. Sattar also participated in a consultation with legal experts on abortion law in Pakistan organised by IPAS (a global reproductive rights NGO) in Karachi.



Dr. Sadaf Aziz (Dean & Associate Professor) has been nominated as a member of the Advisory Committee constituted by the Directorate of Legal Education by the Pakistan Bar Council. IN CONVERSATION WITH

Ms. Aisha Ahmad Assistant Professor at SAHSOL

Describe your journey to becoming a legal academic? Was it a career path that you intended to take?

Like many other Pakistani children, I grew up thinking I would one day become a doctor. My personal rebellion was law—a profession without medicine's constant reminders of mortality but a profession nonetheless! I almost switched to a study of classical languages (nerd) but stuck to law to honour my promise to my brave and wonderful single mother. Having studied international development after my law degrees, I am a socio-legal researcher and academic for now.

Are there particular challenges associated with being a legal academic in Pakistan?

Every profession in Pakistan comes with its attendant challenges. As far as legal academia is concerned, there is a lack of overlap between those interested in law and those curious about its theoretical and historical underpinnings. Moreover, while scholarship in the social sciences is seeing a resurgence, the relationship between sociological phenomena and the legal world is still significantly understudied. Being a legal academic in Pakistan today means having underdeveloped conversations with very few people. I see this changing soon (fingers crossed).

What have you brought to the law department that is uniquely yours?

While I do bring an interest in the political economy of law, socio-legal research and critical legal theories to the department, I do not believe them to be uniquely 'mine'. Any current skills or interests or expertise I bring to SAHSOL today have been shaped and nurtured by so many, not least my colleagues at the law school who were once my professors. Sadaf Aziz's courses on legal theory, Asad Farooq's courses on socio-legal research, Sikander Shah's courses on public international law all shaped my research interests. All three made me much smarter than I was going into law school and I am forever grateful to them for their intellectual guidance and tutelage.



What have you read recently that has helped your work or otherwise inspired you?

So much! I like thinking big and Liu Cixin's "Three Body Problem" trilogy has been the most thought-provoking, challenging and exciting thing I've read in recent years.

Please share your current research interests/work?

My current research pertains to the legal infrastructure around housing and real estate speculation in Lahore, Pakistan. In broader theoretical terms, I am interested in the relationship between law and capital accumulation—to what degree does the law in economies of the global south facilitate profit-making ventures? Instead of seeing real estate development in Pakistan as illegal and dominated by lawless mafias, I am interested in highlighting how the most robust articulations of the rule of law produce the housing crisis Pakistan finds itself in.

Do you involve students in your research or policy work?

I do but want to do more of that! The students I've had at SAHSOL so far have been so very impressive—not just in terms of their abilities to think, argue and read critically, but in their compassion, their extracurricular curiosities and their approach to learning.

Tell us about a time you implemented feedback from your students in your teaching methodology?

Less reading! (still a work in progress)

What do you see as Pakistan's most pressing problems that you can contribute to address?

In my view, one of Pakistan's most pressing problems is the depoliticization of the economy—in our discourse, in our politics, and in our day-to-day consciousness. I hope to help create a new consciousness—one in which today's economic order and its attendant ideological dimensions, material underpinnings and juridical avatars can be understood, debated and transformed by 99%.

"The mediocre teacher tells. The good teacher explains. The superior teacher demonstrates. The great teacher inspires. I am working on being a great teacher someday."




VICE CHANCELLOR'S ALUMNI ACHIEVEMENT AWARDS FOR THE YEAR 2022

SAHSOL takes great pride in sharing that Mr. Saroop Ijaz (BA-LL.B Class of 2008, Lawyer, Human Rights Watch and Adjunct Faculty) and Mr. Altamush Saeed (BA-LL.B Class of 2020, Candidate of LL.M, Lewis Clark Law School, 2022-23) have won the LUMS Vice Chancellor's Alumni Achievement Award for the year 2022.

Mr. Ijaz joined the BA-LL.B program at its inception and was quickly recognised for his diverse talents. In 2013, he was appointed as the Chairperson of the Committee on International Human Rights, Lahore High Court Bar Association and appointed as an Amicus Curiae (Friend of the Court) in several important constitutional cases including the full bench hearing on delimitations of constituencies in the local government elections. He was appointed as a member of an expert group constituted by the National Police Bureau and the United States Institute of Peace on police reforms in Pakistan. In addition to all this work, Mr. Ijaz has also been a diligent instructor at SAHSOL over the last many years providing instruction in areas pertaining to policing powers and oral advocacy.

Mr. Saeed is currently pursuing an LL.M in Animal Law at the Lewis and Clark Law School, Centre for Animal Legal Studies on fully funded Brooks Institute Scholarship (first Pakistani to receive this scholarship). His commendable academic excellence includes International & Comparative Law Scholarship (2021-22) in areas of law, Myint Zan LL.M winner/student of the year (2021-22) for his exemplary interdisciplinary interests and commitment to social and justice in easing the plight of disadvantaged members of the society and excellence in pro-bono service award (2021-22) which has posited extraordinary commitment to pro-bono service at the Michigan Law School.



Why did you join LUMS?

Thinking more deeply about issues that I faced in my personal and professional life, and as a person as a whole. I also found that the LLB degree imparted me with a more empathetic view of the world around me, opening my eyes to realities and real experiences that I couldn't even fathom before.

What do you like most about the law school?

The law school was an incredible experience for me. I have never been in an environment before, where everyone from the classroom staff to the instructors to the administration to the Dean herself felt personally invested in my development and success. The atmosphere was uniquely supportive.

Why should anybody choose a BA-LL.B degree and what are the other opportunities one can avail while studying law?

The LLB opens up possibilities in almost any career and path that can be imagined. I worked with London based barristers exploring the impact of banning the network on education system and consequently the intellectual development of youth in Jammu and Kashmir.



A Survey of Legal Firms in Pakistan

Over the months of September & October 2022 our staff conducted comprehensive interviews with leading law firms, NGOs and other partners for student placement in Lahore. The endeavor is to compile a searchable database for students seeking to develop strategies for their own career development. The firms and organisations were asked to share information about areas of practice, corporate structure, hiring and advancement criteria and processes.

In addition, they were asked to share feedback about SAHSOL graduates and input for further programmatic development. In all, over 19 law firms and three NGOs were thus interviewed, and we plan on carrying out a similar exercise with organisations in other parts of Pakistan. Soon, the cumulate results of these surveys will be posted online in a searchable form for students to be able to make informed decisions as they start to navigate the legal job market.



Faculty Advising

Last year, our advising unit designed and introduced a reflection form for students to complete prior to meeting with their assigned faculty advisor to encourage a more meaningful and structured interaction. In fall 2022, this system is being further enhanced by implementing Zambeel blocks or "advising holds" for all super-senior year students so that every student has an opportunity to receive professional guidance before they graduate from the law school.

Legal Writing Lab at SAHSOL

The Legal Writing Lab instructors from the previous year worked over the summer to produce legal writing manuals. These will be of immeasurable aid to the second cohort of legal writing lab tutors who were trained over the summer months. Some members of the lab will now be working with central advisement unit at LUMS who will provide training to our tutors regarding argumentation & logical reasoning for papers and presentations.
