

IN MEMORIAM: THE HONORABLE JUSTICE (R) FAZAL KARIM



The SAHSOL family is deeply saddened to learn about the passing of our mentor, friend, senior colleague, and tireless torchbearer, the Honourable Mr. Justice (R) Fazal Karim. Justice Karim was a key influence and inspiration to generations of our faculty and students. His magisterial *Judicial Review of Public Action* is a model of Pakistani and comparative scholarship that features prominently in a range of publications and courses emanating from SAHSOL and beyond. Justice sb gave selflessly of his time and wisdom over a long association with the Law School during its formative years. Everyone associated with the School owes a great debt or gratitude to him.

Justice Karim had a wide-ranging career of great distinction in the judiciary and in legal academia. He served on the Supreme Court from 1994 to 1996, and on the Lahore High Court from 1987 to 1993. In March 2023, he was awarded the Hilal-e-Imtiaz by the President of Pakistan for excellence in his field, along with 135 local citizens and foreign nationals. Justice sb was a rare luminary who ascended to the highest court of the land after making his mark as a civil judge in the lower courts.

Notably, he crafted the comprehensive Bench *Book for the District Judiciary*, an authoritative guide catering to the intricate demands of daily judicial and administrative tasks. No other academic could speak with the authority of Justice sb on our district courts. His work "Access to Justice": A Handbook for Civil and Criminal Litigation, proved to be an invaluable resource for legal practitioners and enthusiasts alike.

Presenting the illustrious career highlights of Justice Fazal Karim:

- Appointed as a Civil Judge in 1960
- First Parliamentary Secretary to the Ugandan Government between 1974 and 1976
- Served as Judge at the Lahore High Court from 1987 to 1993
- Elevated to Judge of the Supreme Court of Pakistan in 1994
- Retired from the Supreme Court of Pakistan in 1996







EVENTS AT SAHSOL

Conference on The Constitution of Pakistan at 50: Reading the Past and Charting the Future

SAHSOL hosted 'The Constitution of Pakistan at 50: Reading the Past and Charting the Future', an interdisciplinary endeavour to critically reflect upon the text and life of the 1973 Constitution of Pakistan. An opening statement for the two-day event was delivered by Dr. Parvez Hassan who highlighted the challenges we face in realising a more stable constitutionalism in the country. The Keynote address was delivered by Dr. Moeen Cheema, Associate Professor, Australian National University, who had been Assistant Professor at SAHSOL from 2004-2009. In this talk, he focused on comparative constitutional design by reference to the instruments and institutions capable of ameliorating conflict in deeply divided societies within the Global South. A plenary session focused on Dr. Rohit De's book, The People's Constitution was held. The book provides a detailed account of the strategies, struggles and the social context of constitutional cases fought in the early years after independence.

The conference comprised of three panel discussions. The first panel on Federalism, Resources & Minorities in Pakistan, moderated by Dr. Sadaf Aziz included Mr. Rafay Alam (VP-Punjab, Pakistan Environmental Law Association), Dr. Rafiullah Kakar (Member- Social Sector & Devolution, Planning Commission of Pakistan) and Dr. Sikander Shah (Associate Professor, SAHSOL & Director CCLS). The second panel on perspectives regarding the expanse of rights conferred in the constitution, moderated by Dr. Adnan Sattar had

participation from Dr Ghazal Asif (Assistant Professor, LUMS), Ms. Reerna Omar (Lawyer and Human Rights Professional) and Mr. Salman Akram Raja (Advocate, Supreme Court of Pakistan). Ms. Hiba Akbar moderated the last session on 'Feminist Re-imagining of the Constitution'. Ms. Marva Khan, Ms. Sara Malkani (Advocate, High Court) and Dr. Sarah Humayun were the panelists for the session.

In addition to these panels and sessions, Hamid Khan, Senior Advocate, Supreme Court of Pakistan, delivered a set of illuminating closing remarks that encapsulated some of the major continuing problems of restoring civilian supremacy and constitutional guidance in the country.

Designing and Teaching Effective Law Courses: Pedagogical Training for Legal Academics

More than 21 Deans, HODs, and law instructors from public legal education institutes nationwide participated. The training covered course design for law students, including teaching skills and a lesson demo for feedback, to enhance practical application of new knowledge.





Consultation Workshop on Punjab Protection of Women against Violence Act 2016 for Legal Experts in Pakistan

SAHSOL, Social Welfare Department Govt. of Punjab, Punjab Women Protection Authority (PWPA), and Dastak Charitable Trust collaborated for a discussion on implementing the Punjab Protection of Women Against Violence Act 2016. Experts debated whether the law should be criminal or civil and if enough resources were allocated for enforcement. Suggestions included databases, training, special courts, and swift relief for victims. Mr. Mudassir Riaz Malik from SWD attended, and Mr. Arshad Waheed (DG, PWPA) thanked participants, with appreciation tokens given at the closing ceremony.

The event brought together legal academics from leading institutions across the country and the Honourable Justice Jawaad Hassan delivered a concluding statement.

IN CONVERSATION WITH

Dr. Sikander Ahmed Shah

Associate Professor, SAHSOL Director, Centre for Chinese Legal Studies (CCLS)

Professor Sikander Ahmed Shah, a distinguished founding member of Shaikh Ahmad Hassan School of Law (SAHSOL) at LUMS, currently serves as the Director of the Centre for Chinese Legal Studies

(CCLS) at SAHSOL. He has vast international experience in Public International Law, Human Rights, Corporate Governance, and more. As an author, he has written on "International Law and Drone Strikes in Pakistan." Additionally, Professor Shah has provided legal advice to Pakistan's Foreign Minister and actively contributes to projects related to human rights and criminal justice reform.



1. What subjects do you teach at SAHSOL, and what are your main areas of legal research?

I teach a variety of courses at SAHSOL, some of which include Public International Law, Refugee Rights, Environmental Law, Human Rights and Humanitarian Law, Comparative Constitutionalism, and Constitutional Theory. These are also the areas in which I conduct most of my academic research.

2. Can you describe your journey to becoming a legal academic? Was it a career path you intended to pursue?

From the beginning, I intended to focus on Law and Public Policy. However, in law school, I decided that I would move into academia, specifically in Pakistan. I wanted to work at the grassroots level and engage with societal issues. In this vein, I pursued and completed a PhD in the Social Sciences subsequently.

3. Could you provide some information about the specific activities and contributions of the Centre for Chinese Legal Studies, which you have been leading at SAHSOL?

Through CCLS, we have conducted cutting edge research and teaching on the CPEC (China-Pakistan Economic Corridor) and the BRI (Belt and Road Initiative) in Pakistan. We have also engaged with key stakeholders both within and outside of Pakistan. We have built linkages with the Chinese Government and Universities and will be collaborating with them in the near future. Our main focus has been on economic and social empowerment in Pakistan using China as an example.

4. Congratulations on your PhD! Can you give us an overview of your dissertation's key areas of focus and course of study?

My PhD centered on political theory and democracy, specifically examining how communal rights for minority protection and strengthening local government through federalism can bring political stability to Pakistan.

5. Have you come across any recent readings that have influenced or inspired your work?

Most of the recent literature on the developing world's engagement with international law is quite critical and interesting.

6. In your view, what are Pakistan's most pressing problems that you believe you can contribute to addressing?

Pakistan is currently confronting a multitude of challenges, some originating domestically and others influenced by global developments. These issues encompass economic, social, cultural, and political complexities that pose considerable difficulties in finding swift solutions. As academics, our responsibility is to bring these issues to the fore and promote a serious debate in society so that these issues can be resolved through democratic reform. The objective should be to hold those in power accountable.





DIGITAL PRIVACY IN PAKISTAN: ENDING THE ERA OF SELF-REGULATION

"Digital Privacy in Pakistan: Ending the Era of Self-Regulation", written by Hammad Amin and Maira Hassan Khan, analyses the current data protection framework in Pakistan alongside the future steps that Pakistan aims to take in this regard. This article identifies the dire need to enhance data and privacy protection legal mechanisms as a response to the rise of tech giants and data hoarding companies. The vulnerability of developing countries such as Pakistan is highlighted as they lack the legal mechanisms to protect consumers from data exploitation.

This research paper initially discusses and expands on the concept of privacy in the constitutional framework of Pakistan, as well as in other laws. Subsequently, the paper discusses how tech giants conduct their activities in a manner which shows negligible regard for the data protection and privacy of their users. Issues of user consent and user profiling are highlighted as the practices of big tech companies such as Facebook and Google are discussed. The paper then goes on to juxtapose the US and the EU data protection frameworks in order to highlight the different approaches that both jurisdictions have taken to tackle a common problem.

The California Consumer Privacy Act ("CCPA") is mostly discussed for insight into the US response, and the General Data Protection Regulation ("GDPR") analysed for insight into the EU response. This comparative analysis highlights the different approaches which can be taken to protect consumers from data exploitation at the hands of big tech companies.

Even though Pakistan does not have any specific legislation for data protection, this paper analyses other legislations which partly and indirectly constitute the data protection framework in Pakistan. These legislations include the Contract Act, Consumer Act, and Prevention of Electronic Crimes Act. Furthermore, in order to analyse the steps that Pakistan's legislature intends to take, the paper goes into a deep analysis of the Personal Data Protection Bill of 2021. By conducting a critical analysis of the bill, this paper is able to highlight the protective mechanisms and critique the existing lacunas within the legislation. Through this critical analysis, the paper concludes that Pakistan is in the right direction regarding data protection; however, further work needs to be done to ensure that consumer data and privacy is sufficiently protected.
