Launch of SAHSOL's Pro-Bono Legal Aid Clinic


The event announced the full operation of the LUMS Law Clinic, the organizational center for a range of faculty and student initiatives to promote justice, legal literacy and offer pro-bono legal services. The launch event itself intended to honor the various initiatives undertaken by faculty members and students, as well as community partners, towards expanding access to justice in our community. A credit bearing course, the LUMS Law Clinic, was rolled out in the Spring 2025 semester. Taught by Maira Mumtaz, the course engages students in legal service delivery and experiential learning. For Khula cases, clients are referred by the Punjab Women Crisis Center and for bail cases, the referral agency is the Punjab Prisons Department.

In both types of cases, students begin the assignment with client interviews. This is then followed by the execution of a power of attorney allowing the clinic instructor to represent these clients in Court. Students then commence their case preparation. This includes research, drafting of the plaint or bail application and the preparation of notes for oral argumentation. Students in most cases were able to also assist the instructor in her arguments in Court. In its first offering, the Clinic was able to obtain favorable orders for five clients including khula, orders for maintenance, and other family-related matters. In addition, four clients have been granted bail, and five will be argued once the semester is closed.










Law students demonstrating case work during the launch ceremony of the LUMS Law Clinic



Prison Paralegal Clinic

After a successful term spent in District Jails, Lahore, and Sheikhupura in 2024, the Prison Paralegal Clinic was assigned to District Jail, Kasur this year. Jointly taught by Ms. Angbeen Atif Mirza and Dr. Qadeer Alam, the paralegal clinic combines the scholarship of teaching and learning with legal theory to produce lesson plans aimed at creating informed citizens. This clinic teaches students to navigate complex legal theory, translate it into practical information for laypersons, and design highly interactive lesson plans to deliver legal awareness to prison inmates.



Alternate Dispute Resolution

As a concrete first step towards the establishment of an Alternative Dispute Resolution Centre, SAHSOL collaborated with the Legal Aid Society (LAS) and the Mediation and International Commercial Arbitration Centre (MICADR), to host a first ever 40-hour Mediation Skills Training Program at LUMS. Delivered by the experts Sohail Khoja, Fehmida Ajanee, Shahzar Ilahi, and Sarha Rasheed, the program focused on interest-based negotiation, ethical facilitation, and dispute resolution across legal domains. Timed with the Supreme Court's ADR institutionalization efforts and Pakistan's accession to the Singapore Convention on Mediation, the initiative seeks to develop a cadre of accredited mediators equipped to support time-efficient, cost-effective dispute resolution.



Victory Echoes from LUMS Pakistan to the World: Jean Pictet International Humanitarian Law Competition

Our team for the Jean Pictet International Humanitarian Law Competition made history as the first ever victors from Pakistan. Aizaz Arif (2025), Sakina Zulfiqar (2025), and Asfand Katchela (2026) competed against 140 delegates from 49 countries, including Master's and PhD students specializing in International Humanitarian Law. The team members individually completed a 60-hour certified online module on IHL and engaged in weekly coaching

sessions with an assigned mentor from December to mid-February. Out of the 49 initially shortlisted teams, 39 advanced to compete onsite. The competition entailed approximately 10 preliminary-rounds over five days, culminating in the team advancing to and winning the final after successfully clearing the semi-final collective exercise in Bali, Indonesia. Sakina was shortlisted for the Gilbert-Apolis Best Speaker Award.

Willem C. Vis International Commercial Arbitration Moot

The LUMS SAHSOL team made it to the quarter finals of the Willem C. Vis International Commercial Arbitration Moot in Hong Kong in April 2025, ranking amongst the top 8 out of 154 teams globally. They were recognized with the Eric R. Bergsten Award for Schools prevailing in the Oral Arguments. Team members Sameer Asad Qureshi and Fatima Farooq Chishti honored with Honorable mentions for the Neil Kaplan Award for Best Individual Oral Advocate. The team including Aizaz Arif had earlier won the national round at NUST, Islamabad where they also earned Best Memorandum (Claimant) Award, while Ms. Fatima Farooq Chishti recognized as the Best Speaker. The team was trained at the Dubai International Arbitration Centre in collaboration with the American



University in the Emirates. They also attended the 15th Annual Middle East Willem C. Vis Pre-Moot in Abu Dhabi, UAE. We also extend our sincere gratitude to Irfan and Irfan (Attorneys at Law) for their support to the students to participate at the international level. Their contribution is a testament to their dedication to legal education and a reflection of their broader vision to strengthen Pakistan's presence in the global legal landscape.




The Philip C. Jessup International Moot Court Competition

The LUMS team comprising Ali Hassan (2026), Malik Ahmed Hasan (2026), and Ali Abbas Gilani (2026) and Amna Naqvi earned their place on the global stage through an outstanding performance at the Pakistan National Rounds of The Philip C. Jessup International Moot Court Competition, hosted by Indus College of Law in Hyderabad. Among 32 competing teams, the LUMS delegation secured the top rank in the preliminary rounds and demonstrated remarkable legal advocacy skills, advancing through the Round of 16 and Quarterfinals to ultimately qualify as Semifinalists. The Philip C. Jessup International Moot Court Competition is the world's largest moot court event, bringing together participants from over 700 law schools across 100 countries to engage in complex simulations of international legal disputes.

Pakistan's Feminist Judgement Project cited in Mansoor Ali Shah's Judgement

The Pakistani Feminist Judgments Project (PFJP) was referenced by the Honorable Justice Syed Mansoor Ali Shah in Zahida Parveen vs. Government of Khyber Pakhtunkhwa (CPLA No. 566-P/2024). The case concerned a schoolteacher's challenge to remove her from service during a probationary period without a meaningful opportunity to be heard. In his judgment, Justice Shah emphasized the importance of gender-sensitive judicial reasoning, observing that "how law is written matters as much as what it decides." Citing feminist judgment projects across jurisdictions, including Pakistan's own, the judgment acknowledged the pivotal role of inclusive and equality-affirming language in achieving substantive equality for women. The citation marks a significant moment for the Pakistani Feminist Judgments Project, which reimagines key Pakistani legal decisions through a feminist lens using existing legal principles. The Pakistani Feminist Judgements Project is founded by Marva Khan (Director Academics and Assistant Professor at SAHSOL, LUMS) and Orubah Sattar Ahmed (SAHSOL Alumna and Legal Program Manager, Trial Watch Initiative at the Clooney Foundation for Justice).

Major Events at SAHSOL

Conference, Trainings and Workshops

Futures of International Law

SAHSOL hosted its third annual conference, Futures of International Law in April. Drawing scholars and practitioners from across the globe, including the U.K, Norway, India, and Pakistan, the conference critically explored the evolving relevance of international law in addressing conflict, displacement, inequality, and climate crisis. The conference opened with a plenary that centered Gaza within a broader critique of the colonial and selective underpinnings of international law. Speakers reflected on the silence of legal institutions in the face of atrocity, and the marginalisation of voices from the Global South, particularly Palestine. This set the tone for two days of engaged and reflective discussion on the promises and failures of international legal frameworks. Throughout the six panel sessions, participants grappled with both enduring and emerging tensions within the field. Questions were raised about the disconnect between legal ideals and geopolitical realities whether in humanitarian law's failure to protect civilians, the fragmented legal regimes governing climate displacement and cyber conflict, or the structural inequalities embedded in economic and investment law. Together, these conversations called into question the legitimacy of existing legal orders, while also offering alternative visions rooted in local practices, anti-colonial critique, and global solidarity. The conference concluded with a reflective plenary featuring Dr. Parvez Hassan and Ambassador Zamir Akram, who revisited Pakistan's contributions to international legal development and called for a enewed multilateralism capable of responding to today's most urgent challenges. Looking ahead, participants expressed both skepticism and cautious hope for reimagining international law as a field committed to justice, resistance, and transformation.











SAHSOL's Legal Advocacy on Labour Codes

At the frontlines of reform, Dr. Syed Muhammad Azeem and Muhammad Umar Ali have led a rigorous programme of consultations and research-based advocacy around the proposed Uniform Labour Codes in Punjab and Sindh. They have represented labour interests in key forums, including consultations led by the International Labour Organization and the Punjab Labour Department. They have engaged over 100 stakeholders—from trade unions to civil society—through in-house and regional consultations across Lahore, Karachi, Hyderabad, Faisalabad, and Islamabad.

Their appointment as pro bono legal advisors to the Labour Alliance—Anti Punjab Labour Code underscores their critical support for worker-led platforms. Umar Ali also presented constitutional critiques of the Punjab Labour Code before the Provincial Assembly's Standing Committee on Labour, and both faculty members have advised legislators on reforms to industrial relations and social security laws. Their advocacy has extended to public lectures and academic panels, including the Industrial Relations Seminar co-hosted by the Japan International Labour Federation and the Pakistan United Workers Federation.



LUMS LAW JOURNAL - Young Scholar's Workshop

In April, the LUMS Law Journal (LLJ) held its 2nd Young Scholars' Workshop at SAHSOL. The event brought together young legal researchers from across Pakistan to present draft papers and receive feedback. The workshop fostered a supportive space for young scholars to engage in critical dialogue and strengthen their academic writing. Senior faculty and editors from LLJ offered constructive feedback, contributing to the development of high-quality legal scholarship.



Law for Business Executives Programme at LUMS

In February, SAHSOL and REDC jointly offered the Law for Business Executives programme at LUMS, designed to equip business professionals with essential legal knowledge for strategic and compliant decision-making. Participants explored key areas such as contract and company law, consumer protection, competition law, labor litigation, environmental regulation, intellectual property rights, taxation, and alternative dispute resolution.

Dean's Honour List Ceremony

In February, SAHSOL hosted its Dean's Honor List (DHL) ceremony to celebrate the academic excellence of 57 law students. 


Networking Day with Law Firms



Webinar on Clinical Legal Education and Social Justice

In February, SAHSOL hosted a webinar featuring Professor David McQuoid Mason, a distinguished legal scholar and pioneer of street law education. Professor Mason explored street law's role in access to justice, effective teaching methodologies, and the essential components of an impactful lesson—legal content, policy considerations, interactive strategies, and practical legal advice. By way of example, he showcased street law initiatives in South Africa, Mongolia, Kenya, Uganda, and Tanzania, highlighting their contributions to legal empowerment and human rights. The session concluded with a Q&A, where participants discussed street law's adaptation across legal systems, its relevance to Pakistan, and strategies to expand legal literacy programs nationwide.



Cross Examination in Criminal Cases

Mr. Haider Rasul Mirza (Advocate, Supreme Court of Pakistan) delivered a guest lecture on cross-examination in criminal cases, including rules of evidence, relevancy, admissibility, and the process of chief and re-examination.



Dukhtar Screening and Discussion

Ms. Afia Nathaniel (Film Director) and legal expert Mr. Asad Jamal (HRCP) discussed the legal and social realities of child and forced marriages in Pakistan



Prison Conditions and Reforms

In February, SAHSOL hosted a panel discussion on prison conditions. The session featured Dr. Qadeer Alam, Assistant Inspector General (Judicial) of Punjab Prisons, Ms. Sana Sharif, Senior Program Manager at the Committee for the Welfare of Prisoners, and Mr. Sohail Yaafat, Criminal Defense Investigator at the Justice Project Pakistan. The panelists discussed key issues in Pakistan's prison system from their varied perspectives. The concerns highlighted included prison overcrowding, discrimination, inadequate healthcare, and the urgent need for rehabilitation. There was a healthy debate between the participants, who also took questions from the audience. The event underscored the importance of systemic change and legal reforms for improving conditions and ensuring the welfare of prisoners.


Legal Scholarship in Motion: Pushing Boundaries, Shaping Conversations

Dr. Adnan Sattar

Assistant Professor, SAHSOL

Describe your journey to becoming a legal academic? Was it a career path that you intended to take?

I came to the academia through a circuitous route following sojourns in journalism, international law and human rights practice. The great American novelist, James Baldwin, once said, 'the price you pay for following any vocation or calling is an intimate knowledge of its ugly side'. In my case, it was a realisation that the seemingly exciting transnational domain of human rights and humanitarianism offered little room for asking unsettling and inconvenient questions. That's what nudged me in the direction of the legal academy. A PhD in law provided me with the technical wherewithal which I needed to make the move.

Are there any challenges associated with being a legal academic in Pakistan?

Yes, quite a few. For a start, we lack locally produced and context-specific scholarship and textbooks with the result that much of our time is taken up in either producing new teaching material or tailoring foreign scholarship to the local context. That is beginning to change with new scholarship coming out of Pakistan especially in the area of constitutional law. But we still have catching up to do with other countries in the global South, for example, India and South Africa. Second, while LUMS itself is something of an oasis in the wilderness, we do not have the kind of access to material (books, journals, archives, databases etc.) and financial resources which make for a vibrant and thriving research-oriented environment.

What have you read recently that has helped your work or otherwise inspired you?

I just finished reading Abdulrazak Gurnah's novel Paradise. It is a wonderful book that weaves African folktales and Quranic and Biblical stories into an account of a boy's life who is sold into bonded labour while his country is fast turning into a playground for European colonial powers. The book serves as a reminder of the abiding relevance of history to what we write and teach and the power of fiction to illuminate the richness and complexity of human experience which inevitably drops out in scholarship – at least legal scholarship.

What have you brought to the law department that is uniquely yours?

Nothing really. I would make something up if it were a job interview. I won't be presumptuous enough here to claim something as exclusively mine – except the trials and tribulations that I have been through, and the memories stored up in my mind.

Please share your current research interest/work.

Taking off from my earlier work on the paradoxical relationship between human rights and criminal punishment, I'm currently canvassing punitive tendencies within human rights movement in Pakistan: the way human rights advocates seek to trigger criminal law and lend support to tougher punishment in the name of protecting human rights. Also, on my research agenda is (hopefully) a blistering critique of the recent judgment by the Supreme Court giving a nod of approval to military trials of civilians. That represents one of the darkest moments in the history of the court and must be reckoned with as such.

Do you involve students in your research or policy work?

Yes, several students have worked with me as research assistants over the past five years and provided invaluable support as well as original insights that have fed into whatever little I have published and presented at academic conferences.

Tell us about a time when you implemented feedback from your student in your teaching methodology.

One tries to be alert to students' feedback all the time. The challenge is to strike a balance between what students prefer in terms of curricular content and methodology on the one hand, and the professional responsibility an instructor has to adequately cover the topic that they are assigned to teach. I'm not a great fan of power points but I make it a point to use and share slides in every course because I heard from students early on in my teaching career that they appreciate having slides as reference points both for class discussion and revision. Another concrete example is the inclusion of some literary material (poems and short stories) in courses on public law and legal practice which is informed by the energy and interest students demonstrate in engaging with such material perhaps as an antidote to drab and arcane legal stuff that we inevitably subject them to all the time.

What do you see Pakistan's most pressing problem that you can contribute to address?

Systematic dismantling of democratic norms/institutions and consolidating military hegemony. Democratic backsliding in our country – as elsewhere in the world – is something we should all worry about. As an ordinary teacher, I can only aim to be a Socratic gadfly encouraging critical thinking among students regarding what is being sold to us as the 'national interest'.



Mooting at SAHSOL: Sharpening Voices, Shaping Arguments



A Textbook on Legal System of Pakistan

Muhammad Imran co-authored 'Legal System of Pakistan' with M. Saifullah Sohail (Additional District & Sessions Judge), and Rana Shehzad Khalid (PhD Candidate, Brunel University, UK). 
